The City of Benicia is accepting applications for the position of Paramedic/Firefighter. The City currently has two (2) vacancies. This recruitment will also be used to establish an eligibility list for future vacancies that may occur while the list is still active.

Future Salary Increases: In addition to advancement through the salary range due to merit increases, there will be an across the board 2.25% Cost of Living Adjustment on 7/1/17. There will be another 2% Cost of Living Adjustment on 7/1/18.

ADDITIONAL COMPENSATION (in addition to salary rate listed above) and Benefits include:

CalPERS Retirement: 3% at 55 plan for "classic" members; 2.7% at 57 for members considered PEPRA. If you are not sure which formula would apply to you please call the Human Resources Department at (707) 746-4205.

Uniform Allowance: \$75.00/month.

Educational Incentive: \$70/month for 30 college units; \$210/month for AA Degree; \$280/month for BA/BS Degree.

Holiday Pay: Effective 7/1/17, employees will receive holiday pay in the amount of 0.5% of base pay each month. Effective 7/1/18, this amount increases to 1.25% per month.

Work Schedule: 48/96 schedule.

Dental/Vision insurance: Premiums fully paid by City.

Kaiser: choice of 3 Kaiser plans available; co-pays/deductibles vary between plans.

IMPORTANT: In order to be eligible to test with the City of Benicia for this current selection process, candidates need to have completed the following at the time of application:

1) Successfully passing the written exam through FCTC within the past 12 months and be on the list provided to us by FCTC as of March 3, 2017.

DISTINGUISHING CHARACTERISTICS:

DEFINITION:

Under general supervision to perform advanced life support, emergency medical services and to engage in firefighting, rescue and all other suppression and prevention activities in protecting life and property; to drive, operate and maintain all fire department apparatus and equipment; to conduct, assist and participate in training programs, to participate in inspections and related fire prevention activities, public education, and to do related work as required.

DISTINGUISHING CHARACTERISTICS:

This classification encompasses the full range of Firefighter duties in addition to performing as a Paramedic.

REPRESENTATIVE DUTIES / QUALIFICATIONS:

ESSENTIAL FUNCTIONS OF THE POSITION:

Responds to fire alarms, emergency medical calls, emergency rescues, public service calls, or other alarms which necessitate the mitigating of a situation which threatens life or property;

Drives and locates equipment in the proper place at scene;

Effects rescues; lays hose lines and operates apparatus pumps and aerial apparatus;

Attacks fires and directs fire streams; operates communications equipment;

Performs a variety of routine maintenance and repair tasks, including the inspection and minor repair of equipment;

Studies and reviews fire department rules and regulations, fire hazards, and firefighting techniques;

Participates in drills, training sessions and exercises;

Attends to victims in emergency medical situations using accepted paramedic practices, to include performing techniques such as medication administration, establishing intravenous lines, endotracheal intubation, electrocardiogram interpretation, vital signs, and advanced patient assessment;

Communicates via radio or telephone with the appropriate base station hospital taking appropriate action to preserve life or reduce suffering;

Prepares medical reports, and participates in prospective and retrospective quality assurance activities.

OTHER RELATED DUTIES:

Performs a variety of routine maintenance and repair tasks, including the inspection and minor repair of equipment;

Participates in inspections and maintains a clean and orderly condition in and about the station;

May be assigned to prepare various reports;

May be required to respond to alarms during off-duty hours;

Meets the public and deals with various officials and citizens in furthering the public relations of the department;

Participates in training activities with the fire department, hospitals and other agencies;

Studies and reviews local, county, state and departmental paramedic regulations, ordinances, protocols, and policies;

Teaches emergency medical care skills such as: EMT, first aid and CPR to city employees, the general public, or other allied agencies;

As assigned serves as Acting Engineer or Acting Captain and performs related duties as assigned.

DESIRABLE QUALIFICATIONS:

Experience as a Paramedic in an active progressive paramedic program accompanied by experience as a firefighter in an active progressive firefighting organization is highly desirable.

Ability to:

Learn the operations, use and maintenance of modern paramedic equipment and techniques;

Learn local, county, state and department rules, regulations, policies, procedures, protocols, and ordinances;

Comfort and deal effectively with distraught victims and families;

Learn firefighting methods and techniques, street and hydrant locations, major traffic arteries, and target fire hazards;

Learn to drive and operate pumpers, trucks, ambulance and aerial apparatus with care and safety in accordance with traffic laws and ordinances;

Maintain proficiency in basic and advanced life support techniques;

Analyze emergency situations and adopt effective courses of action;

Communicate clearly and effectively; act quickly and decisively in emergencies;

Understand and carry out orders given in person, by radio, telephone or in writing;

Establish and maintain cooperative relationships with fellow employees, supervisors, and the public.

MINIMUM QUALIFICATIONS:

Experience and Education:

Paramedic:

Graduation from a paramedic training program that meets the requirements for licensing in the State of California by date of appointment.

For out-of-state candidates: Must possess a valid National Registry certification at time of application. Must have applied for a State of California Paramedic license by time of application and must possess a valid State of California Paramedic License by time of appointment.

Certification in Advanced Cardiac Life Support by date of appointment.

Certification in Cardiopulmonary Resuscitation (CPR) by date of appointment.

Successful completion of High School or possession of a G.E.D.

Fire Fighter I:

Successful completion of a recognized regional fire academy course, or equivalent (training to the level of Firefighter I) prior to appointment.

For candidates with Department of Defense (DoD) or out-of-state certifications: Must possess a Fire

fighter I Certificate issued by another State or the DoD with an IFSAC and/or Pro Board seal. You will be required to provide certificates with IFSAC and/or Pro board seals showing you are certified to Fire Fighter I and Haz Mat Awareness/FRO.

Accreditation and License Requirements:

Accreditation by the County of Solano is required within two (2) months of appointment.

Must possess a Valid California Driver's License at time of appointment. Within six months of successful completion of probationary appointment, must obtain and maintain the Firefighter Endorsement as issued by the State of California Department of Motor Vehicles.

MEDICAL AND PERFORMANCE STANDARDS:

Prior to appointment, must meet job related medical, psychological, vision, background investigation, and physical performance standards. All new employees will be fingerprinted.

After employment, employee may be required to pass periodic medical examinations and physical performance tests. Maintain good physical fitness condition through an ongoing physical fitness program.

Willingness to attend meetings and training classes; maintain Continuing Education requirements; willingness to work a 24 hour shift, overtime, weekends, on call and on holidays, under adverse or hazardous conditions; willing to work in any station in the City on short notice; willing to perform repetitive work to completion; conform to all rules and regulations of the Fire Department and Paramedic policies and procedures. Maintain a high level of interest in continued self-development and education.
